Hello,

My name is Kevin Raymond, after one year on the job I have learnt a lot about PLEDCO and what we are trying to accomplish. I inherited two great programs that directly address what we are lacking in the region.

Primary Producer Incentive Program (PPIP) – This program allows Trappers/Fisherman/Wild rice harvesters to apply for a loan with a PLEDCO grant attached to it. I believe this program directly addresses those most affected by the closure of the Bombing Range.

Business Incentive Program (BIP) – This program will help entrepreneurs and existing business's through mentorship and networking. As with the Primary Producer Incentive Program, BIP offers a loan with a PLEDCO grant attached to that loan.

With these programs running smoothly I have decided to focus on internal operations and efficiencies. This year we completed a board retreat to go over policy and procedure in order to remain relevant and current. All updated materials can be found on the PLEDCO.CA website for you to view. We also undertook a 5-year evaluation (Lead by MNP) of PLEDCO to be completed this fall. I am confident there will be steady and positive growth shown on this evaluation.

Sources of Funding

2016 - 2017 BUDGET

We receive our cheques from the Trust Manager at the beginning of April, and this becomes PLEDCO's income for the new fiscal year beginning April 1, 2016 – March 31, 2017. As specified under the Agreements, PLEDCO maintains four bank accounts through which this money is distributed. This amount was allocated to the accounts as follows:

PLEDCO budgeted \$710,338.75 of this income for economic development and infrastructure projects in the four communities.

In this fiscal year, **\$182,543.25** was allocated for **Operations**. PLEDCO is allowed the greater of 15% or \$175,000.00 in total from the Federal Accounts each year, while Saskatchewan permits 25% of annual income from its portion to be transferred to Operations.

April 1st, 2016 - March 31st, 2017 - Successful Applicants

Ile-a-la-Crosse

Ile a la Crosse – Water/Sewer upgrades

PLEDCO Contribution: \$25,000

Ile a la Crosse is currently undertaking a four-phase water & sewer project which involves revamping our community sewer system which involves upgrading the water treatment plant and lift stations as well as replacing aging sewer lines. The total project cost is \$6.5 million. Ile a la Crosse is expected to pay \$108,333 a year directly out of their operating account.

Beauval

Beauval Development Inc. – Community Garden Project

PLEDCO Contribution: \$13.330.65

Beauval is currently operating a Market garden like the one recently done in Ile a la Crosse.

Beauval's market garden supplies fresh produce to its residents during the summer/fall months.

Beauval Development Inc. - Strategic Planning

PLEDCO Contribution: \$3,500

Beauval Development Incorporated will continue to grow and serve Beauval and the region. They have decided to do a strategic plan this year which will help guide their efforts in the short term as well as planning for the future.

Beauval Development Inc. - Blueberry Hills Cube van purchase

PLEDCO Contribution: \$20,000

Beauval Development Incorporated has purchased a new Cube van to increase their hauling capacity in order better meet the increasing demand for Blueberry Hills Water.

Lori Burnouf – Tavern feasibility

PLEDCO Contribution: \$4.875

Lori is currently in the feasibility stages of a proposed tavern style restaurant that would be located at the Beauval forks.

Beauval - Water/Sewer upgrades

PLEDCO Contribution: \$25,000

Beauval is in the process of constructing a new water treatment plant for the community. The new plant will utilize a modern day biological filtration process that will better assist in the removal of iron, manganese and ammonia from the water supply and reduce chemical consumption in treating the water. Total project cost is \$3,894,750.

Cole Bay

Cole Bay – Van Purchase

PLEDCO Contribution: \$15.750

Cole Bay indicated they needed a new transport vehicle to ferry workers to and from job sites as well as other municipal business. Their current vehicle was starting to see wear and tear becoming inconsistent.

Regional Projects

Beaver River – Business Incentive Program

PLEDCO Contribution:

\$55,000

PLEDCO's Business Incentive Program has enjoyed another successful year. As part of this Disbursement applicants are given access to business loans with a PLEDCO grant attached to it. Successful applicants are also able to utilize business consultants, Marketing supports, as well as a mentorship component.

Beaver River – Primary Producer Incentive Program

PLEDCO Contribution:

\$95,234.92

PLEDCO's most successful program to date. Applicants who are Trappers/Fisherman/Wild rice harvesters are able to get a loan from Beaver River up to \$10,000 with a \$4,000 grant attached to the end of it.

North West Communities – Feasibility Study for a wild rice processing plant

PLEDCO Contribution:

\$7,284.25

NWC is currently in the feasibility stages of a proposed wild rice harvesting plant located in the PLEDCO region. Currently the majority of our wild rice goes to La Ronge.

Beauval/Ile a la Crosse – Historical Fort Black Trail

PLEDCO Contribution:

\$31,500

The historical fort Black Trail was repaired/widened this past spring and is now usable for ATV's/Skidoo's and hikers.

PLEDCO - 2016-2017 Strategic Planning

PLEDCO Contribution:

\$30,172.90

Every year PLEDCO's board has a strategic planning session meant to clearly outline our objectives going forward and to measure our past successes. This year's session was held in Saskatoon on December 2-4 2016.

SEDA - Changemakers Initiative

PLEDCO Contribution:

\$7,800

Saskatchewan Economic Development Association presented PLEDCO with an opportunity to showcase the new Ile a la Crosse fish plant as a Changemaker. A 30 second commercial was produced and shown province wide for the spring/summer of 2017.

PRC – Deposit on building materials

PLEDCO Contribution:

\$41,614.07

A down payment on building materials was made for the proposed construction of a Gas Bar at the Beauval forks.

PRC – Strategy Planning

PLEDCO Contribution:

\$14,586.35

Primrose Resources Corporation recently attended a strategy planning session for the 2017-2018 year. During this session PRC was able to plan for the immediate future as well as set some long term goals.

Criteria/General Guidelines for consideration of Projects or Programs

The standard application requirements are:

- 1. A business outline or plan that proves the viability of the business project
- 2. A completed PLEDCO Application for Economic Development Assistance
- 3. Supporting documentation to the business plan (support letters, confirmation of approved funds from other agencies, proof of existing contribution/equity, etc.)
- 4. Historical financial data (if applicant is an existing business/contractor)

The following considerations are given to completed applications when they are received:

- Does the project or program create sustainable economic development?
- Does the project or program create wealth?
- Does the project or program create employment?
- Is the project or program incremental to the economy?
- Does the project or program diversify the economy?
- Does the project or program foster entrepreneurship?
- Does the project or program increase business decision-making capacity?
- Does the project or program support youth development?
- Does the project or program encompass all 4 communities?
- Are the management skills for the project or program apparent by the applicant?
- Is the application thoughtful or creative?
- Are there any personal contributions to the project or program?
- Does the project or program diversify funding sources?

All applications must be received a minimum of **7-days prior** to a regular board meeting in order to be considered for approval. This gives the Executive Director some time to do some fact-checking if necessary and inquire on the status of other funding applications and clarification of any submitted documentation.

Also taken into consideration are the project and program qualifications as presented in the Canada – Primrose Lake Community Economic Development Agreement, Schedule "A":

- Attracting investment to the Primrose Lake Area;
- Supporting the viability of the local economy and increasing the participation of community members;
- Supporting community adjustment to economic realities;
- Promoting community planning and strategies;
- Supporting the creation of physical assets;
- Conducting economic and business research;

- Supporting investment in skills, knowledge, and competencies development in support of strategic objectives;
- Enhancing technology commercialization and adoption;
- Improving business productivity [i.e. new machinery, training, business, information]
- Developing new or enhancing existing markets [supplier, domestic, international];
- Addressing systematic business issues; and;
- Otherwise increasing the development and diversification of the Primrose Lake Area economy.

PLEDCO Background & Contact Information

The Primrose Lake Economic Development Corporation (PLEDCO) was formed as a result of the Agreements for economic development reached with the Government of Canada and the Government of Saskatchewan. The Agreements were the result of negotiations that came about from our loss of the use of land included in the Primrose Lake Air Weapons Range.

PLEDCO is the manager of the Trust funds granted by the senior levels of government for the long term benefit of the four communities affected by the Air Weapons Range – Cole Bay, Jans Bay, Beauval and Ile-a-la-Crosse. PLEDCO's mandate is to promote and assist in the economic development of the four communities while ensuring that the funds are preserved and wisely utilized for this purpose.

\$2,000,000.00 of the original \$4,500,000.00 placed in the Trust by the Government of Saskatchewan for an Elders Initiative Program, was paid out by the deadline date of June 30, 2009. This left a total of \$17,500,000.00 in the Trust Fund from the original \$19,500,000.00. An Agreement with the Bank of Nova Scotia Trust Company seals this money in for a period of 99 years, or until the equivalent of \$15M has been earned from the annual earnings of the Trust at which time the money will be paid out to PLEDCO.

Since the Trust's creation, the money was invested in government bonds and blue chip equities. This ensures a reasonable return in spite of financial market swings. The Board of Directors determines the use of the annual income according to the guidelines set in the Agreements. Generally, the money is used in four main categories – business and infrastructure, scholarships, research and business planning, and operations.

PLEDCO must operate within the guidelines of the Agreements it has signed with Canada and Saskatchewan and the Trustee (Bank of Nova Scotia Trust). The Agreements specify how PLEDCO is governed, the use of the funds, and operating and reporting requirements. The Government of Canada and the Government of Saskatchewan can each appoint two ex-officio Directors to the PLEDCO Board of Directors. The Municipal Councils of the four PLEDCO communities each appoint two Directors and the Municipal Directors then elect their Officers and hire an Executive Director.
