#### Q&A

- Tony Durocher presented to PLEDCO Board a write-up from the Elder's Group in Ile-a-la-Crosse

   the group has put together an Elder's Transportation Program and wants to work with PLEDCO
   on sustaining this program. William Caisse suggests that gas should be covered.
- Louis Gardiner suggests to PLEDCO to develop an Elder's Strategy from PLEDCO Board and to not forget the history of the Agreement.
- Patty Shaw presented some information to the general assembly about the Primary Producer program and that the idea came about as a result of the removal of the NDF program through the Provincial Government. Individuals can apply for loans up to \$10,000 for commercial fishing, trapping, and wild rice harvesting.
- Mervin Bouvier read a statement to the assembly on behalf of the Metis Local of Ile-a-la-Crosse regarding PLEDCO make-up and involvement of Metis people in the communities and that decisions made by PLEDCO should include consulting the Metis people. Louis Gardiner reminded the assembly that the Agreement were made with the four municipalities and the Federal and Provincial Governments.
- Suggestions from the assembly to work towards Elder's Initiatives and should be included in the strategic plan moving forward with PLEDCO.
